### President's Report

St Pauls United Church of Christ March 16, 2025

Members and Friends of St Pauls,

St. Pauls United Church of Christ is a community called by God to action – for each other, for our faith and for our City.

#### Our community continues to respond forcefully to this call!

I am happy to report that St Pauls continues in its strong tradition of thoughtful leadership and stewardship, acting forcefully on the six pillars of St Pauls' Strategic Plan:

- 1. God is calling us to grow towards each other
- 2. God is calling us to grow toward God together
- 3. Increasing diversity in our Partnerships and our Congregation
- 4. Living our faith in an age of injustice
- 5. Using our building for service and mission
- 6. Tending our finances faithfully

My highlights of the past year include:

- Accelerating the growth of St Pauls, with our attendance growing by an average of 20% per year for the last three years, driven by increased engagement with longstanding church members, our investment in families with children and expanded new member classes.
- The financial strength of our Congregation. Thank you all for your generosity!
  - Another strong, successful annual pledge drive, led by Jack Lyons. We exceeded \$1m in pledges for the first time, with 265 total pledges – a resounding record on both fronts!
  - A successful conclusion to Phase II of our Capital Campaign to Expand and Elevate our Openness, with over \$3.1m pledged.
- Successful reinvigoration of St Pauls' governance and Church ministries, including a successful
  update to our by-laws. We successfully expanded our Nominating committee and placed over
  40 church members within updated, enlivened ministries that support the work of our church in a
  meaningful way. We are already seeing the benefits of this new structure, with more effective
  ministry operations and increased engagement amongst church members.
- The continued expansion of our Children's ministry, with a robust Sunday School, Children's Choirs, Bible-off-Broadway and mission trips. St Pauls is a safe, loving place for all, and especially for families with children.
- We confirmed and energized our engagement and support of Lighthouse Church, with an
  updated and renewed covenant and the establishment of a joint committee between the two
  congregations.
- Continued support of our six migrant families, and the initiation of a Migrant Taskforce to discern St Pauls' role in supporting future migrant efforts. Thank you especially to David Brown, who has been St Pauls' lay leader in supporting these efforts.

I've relied heavily on many of you for counsel and support. Thank you especially to Pastors Matt, Jeff and Liz, our dedicated staff, the members of the Church Council and to all the volunteer members that serve our Ministries. St Pauls is strong because of each of you.

I'm especially grateful for Pastor Matt, who has been a strong partner to me throughout my time as Congregational President and continues to impress me with his bold leadership, thoughtful management and steady care for our Congregation. Thank you Matt for your continued dedication to St Pauls and for shepherding our Congregation as we make a bold impact on our City.

This is my final annual meeting as Congregational President. I'm very proud of what we've accomplished together and grateful for the patience, grace and support each of you has shown to me these past four years. It's been my pleasure to serve and I'm excited to support Lydia as she steps into the role. There's so much good to come!

## 2024 Annual Congregational Meeting Minutes

St. Pauls UCC | Annual Meeting | March 3, 2024

#### **Call to Order**

President Ben Emmrich called the meeting to order at 11:25 AM

#### **Opening Devotional**

Pastor Matt led us in an opening prayer.

#### Remarks

#### Ben Emmrich, President of the Congregation

Ben welcomed everyone attending in person and virtually.

Ben reminded us of the importance of being rooted in the 6 pillars of our 2020 Strategic Plan.

He encouraged everyone to use the Church Center app and upload pictures to go with their individual profiles.

We will hold a special meeting on June 2<sup>nd</sup> to:

- Review updated Bylaws that are currently being drafted.
- Vote on a new committee structure that is intended to increase congregational engagement and build relationships among members
- Elect members to serve on the new committees
- Discuss progress with the Capital Campaign

Ben thanked Matt, Jeff, and Liz, the church staff, and the Council for all they do for St. Pauls

#### Remarks

#### Matt Fitzgerald, Senior Pastor

Matt welcomed the members from Lighthouse Church in attendance.

Matt will be traveling to Scotland on a grant from the Lilly Foundation to meet with a group of Pastors. The Lilly Endowment Fund provides funding to help pastors "live well into their call."

Questions to keep asking: How to invite new people from outside the church?

How to make new connections within the church?

#### **Approval of 2023 Annual Meeting Minutes**

Sally Fletcher made a motion to approve the March 2023 annual Meeting minutes. Carrie Brueggers seconded the motion. There was no discussion. Minutes were approved.

#### Financial Report - Sally Fletcher

- There were budget surpluses in 2021 and 2022.
- We had shortfall in 2023 in operating income.
- The 2022 budget surplus of \$300,00 surplus was the result of several factors: the estate gifts mentioned in Ben's remarks, the forgiveness of the PPP loan, and spending that was 6% lower than budgeted.
- The proposed budget for 2024 is balanced.
- Spending of money coming from bequests is limited to 5% of the operating budget in any one vear
- We have applied for another Employee Retention Credit of \$160,000. We haven't received a response yet.
- Sally explained the Knaphurst Funds can be used for building upgrades.
- The proposed 2024 budget includes a 60% cut to our donation to OCM Illinois Conference. IL Conference hasn't been sufficiently responsive. The \$12,000 remaining
- in the proposed budget is on par with the level of giving from other churches in the area.

Kurt Hansen moved to accept the budget as presented. Kevin seconded the motion.

There was discussion about ways in which we could work with and support the Conference as individuals and as a Church.

Nancy Bingaman made a motion to add to restore the budget line to the Illinois Conference by adding \$18,000 to that line item and pay for the resulting deficit from St. Pauls reserves. Lynn Dykstra Davis seconded the motion.

During the discussion, it was recommended that a study group be assembled to dig deeper into the spending for the Illinois Conference.

The counted vote on the motion results:

online: votes from those attending virtually: 1 yay 5 nay in-person 6 yay 71 nay

The motion did not carry.

Discussion turned back to the whole proposed budget.

Kurt Hansen moved to accept the 2024 budget as presented. Kevin seconded the motion.

By voice vote in the room and virtual votes, the motion carried.

Ben made a motion to update and renew our Covenant with Lighthouse Church. Philip seconded the motion.

Discussion: As part of that renewal a committee with members from both churches has been created that will be in place for the duration of the Covenant (ending March 2027)

More details are included in the Annual Meeting packet.

Char Damron called the Question. Carrie Brueggers seconded it.

The motion to renew our Covenant with Lighthouse Church carried.

#### "Expanding Our Openness" Capital Campaign update:

Members of the Capital Campaign Committee shared progress to date. We will defer a vote until our special meeting in June 2024 because we are waiting for more information from Bulley and Andrews and Larry Kearns.

The meeting was called to order at 11:30 a.m.

Matt Fitzgerald, Senior Pastor, opened with a prayer.

A quorum was present

in person and online.

Ben Emmrich, President, reviewed St. Pauls five strategic pillars

Pillar 1: Grow towards each other, grow toward God together

Pillar 2: Increase diversity in our partnerships and congregation

Pillar 3: Live our faith boldly in ages of injustice

Pillar 4: Use our building for service and mission

Pillar 5: Tend to our finances faithfully

Ben thanked Karen Johnson, for her leadership and dedication to the Expand and Elevate Our Openness during her Presidency.

Ben made a motion to proceed with the Phase II construction in 2025 using raised capital funds, with an estimated \$900,432 balance to be paid from the St. Pauls investment funds, not to exceed \$975,000. And secure a bridge loan until all pledged funds, 2.2 million dollars are received in 2026. After a few clarifying questions, Kirk Hansen called for a vote on the questions. Philip Cendeno-Smedley seconded. The motion passed unanimously both in person and online. Ben thanked the Capital Campaign committee for all of their hard work and dedication to the project. Andrew Broderick, Chair of the Nominating Committee, made a motion to install Greg Basil as Vice President of the Church Council until March of 2026, to replace Renae Bradshaw, who needs to step away for personal reasons. Winnie Kearns seconded the motion. The motion passed unanimously both

Nathan Chamberlin, Chair of the Invitation and Communication Ministry asked people to complete their Church Center registrations and to add their photos to the directory.

Jeff Carlson, Associate Pastor, closed with the Lord's Prayer.

## Senior Pastor Matt Fitzgerald Annual Report

Dear Saint Pauls,

As we look toward our 182nd year as a church, I am full of hope and gratitude for Saint Pauls.

Worship attendance continues to trend upward, regularly matching or increasing our 2024 numbers, and our pre-pandemic attendance. Once again, Bible off Broadway rallied dozens and dozens of young children and galvanized our Sunday School program. A huge thank you to all who made that production such a wonderful celebration, and a marker, both in form and content, of what makes Saint Pauls unique. Our recent New Member classes brought us many remarkable new siblings. On many Sundays the choir stalls could barely hold another singer. These numbers are meaningful because they tell the story of an energized and vibrant church. An energized and vibrant inclusive, forward-thinking, Christ-loving, immigrant-embracing, LGBTQ affirming church. And the world needs our sort of church these days. Perhaps now more than ever.

When the story of 2024 is told, it will begin with the story of our ongoing commitment to migrant families; in particular our commitment to the five we housed in the summer, and the family we housed until February of this year. Saint Pauls was an immigrant church. Saint Pauls is a home to migrant families. Rather than becoming paralyzed by abstract political questions, we followed Jesus and made room in the inn. Endless thanks to David Brown and his faithful team of volunteers, especially our growing ranks of interpreters, and Geoff Gist, our member, whose gifts as an attorney have helped our migrant friends immeasurably.

An equally spectacular chapter will be devoted to the successful conclusion of our Campaign to Expand and Elevate our Openness. Thanks to the pandemic, this fundraising effort took longer than anticipated, and the project's costs grew more than we had hoped. On the other hand, we raised much more money than we thought possible! Indeed, with Jana O'Brien at the helm, we more than doubled the amount professional fundraisers thought we could raise. You did this because you value inclusivity, and remain committed to being a church for all people. I cannot wait for the work to begin! Listen for the joyful sound of jackhammers in the city next month!

The success of the Capital Campaign makes the outcome of our 2025 Annual Giving Campaign even more remarkable. Thanks to Jack Lyons, his team, and your incredible generosity, we just wrapped up the most successful Annual Campaign in Saint Pauls history! Jack has done a remarkable job leading our Giving efforts over the past three years. We owe him such gratitude.

Church polity and governance have never been the most exciting part of any tale. And yet, the changes we adopted one year ago, are resulting in truly exciting growth for Saint Pauls. Our governance changes were made in hope of increasing engagement, and helping church members drawing closer to

one another. I am so glad to report that I witness both of these happening at Saint Pauls. Our members know each other better than they did one year ago. We are becoming better at folding new members into the fold, and at identifying gifts and skills within the congregation.

## Church Buildings and Grounds Annual Report

The committee has been developing a Facilities Project Planning Document to maintain proper recordkeeping of all of St. Pauls work around the building, parsonage, and grounds. This will help us in planning for future projects. Thanks to my great committee!

#### Completed projects include:

- Successfully completed semi annual maintenance of HVAC system
- Major repair to kitchen exhaust system completed
- Ran two new 20-amp service outlets from boiler room to kitchen
- Completed successful fire inspection (our system will need to be replaced in future)
- Completed tuck-pointing for entire entry of side walls/landing at Fullerton entrance
- Updated basement showers with highly efficient shower heads and curtains
- Sanded and refinished Kemper and main court area entry doors
- Water make-up tank construction complete and will now be installed early April, 2025
- Replaced water pump on boiler number two
- Rewired induction motor and replaced contactor on boiler number one
- Replaced ice machine in kitchen
- Completed painting of staircase to sanctuary balcony and upstairs landing
- Completed painting of former migrant housing rooms and staircase
- Competed gutter seam repair and tuck pointing on Orchard side of church
- Along with the green team, relocated plants from the Orchard Street to Fullerton
- Replaced light fixtures with new compatible LED ballast and LED lights in confirmation room next to social hall
- Replaced Fullerton Street electronic signage
- Painted parsonage
- Replaced old commercial kitchen faucets
- Painted yellow parking lines and numbers in parking lot
- Repaired damaged ceiling in pastor's bathroom, painted and installed new vanity and faucet
- Plastered and painted main floor north bathroom

#### Some of the Plans for 2025 include:

- Replacement of the parsonage front porch
- Replacement of motor/pulleys on HVAC system above sanctuary
- Replacement of vacuum pump components in boiler room
- Cut-out and replace the water make-up tank in boiler room
- Placement of Saint Pauls House-stained glass window in stairway next to pastor's office

Our operating fund has been running at an annual deficit, compared to actual costs, which we have had the luxury of doing by using the generous Knaphurst fund. We will continue to use the Knaphurst fund for our large projects, but should be aware that our operating budget will need to significantly increase if that fund were to be completely depleted.

## Giving and Finance Ministry Annual Report

St. Pauls United Church of Christ | Report for the Congregational Meeting March 16, 2025

#### 2024 Highlights

- We received pledges from 250 households, indicating an intent to give \$975,000 in pledged income. At year's end, we received 92% of the budgeted pledged amount, a shortfall of \$95,258.
- We budgeted and received an estate gift from Hazel Vespa, 4% of which we can use in 2024, totaling \$83,083. The balance was credited to our investment account with United Church Funds.
- St. Pauls made an Employee Retention Credit Claim and budgeted a credit of \$167,826; we
  have not received it yet, but have received reassurance from the agent who submitted the
  application that it will be processed.
- Use of church facilities, inclusive of Little Lights, the summer camp program, and parking fees was 79% of the budgeted amount, primarily due to Little Lights expenses exceeding revenue.
- Total operating income of \$1,254,925 was 76% of budget.
- Total operating expenses were 97% of budget. Savings in salaries, benefits and taxes; financial
  administration; office expenses; worship and congregational life; invitational outreach; youth and
  children's ministries; and activism and advocacy were offset by greater than budgeted expenses
  related to building operations and improvement; and music.
- We ended this year with an operational deficit of \$358,107 vs. a budgeted deficit of \$38. Our
  operational deficit would have been \$190,281 had we received the Employee Retention Credit.

#### **Investment Funds**

In 2024, global stock markets saw substantial growth with periods of volatility, driven by technology and healthcare sectors. Bond markets benefited from declining interest rates. Overall, stocks performed well while bond returns improved from depressed levels in 2023.

Since 2013, United Church Funds has managed St. Pauls' investments. They offer a range of professionally managed, diversified and socially responsible investment funds exclusively to United Church of Christ Churches and ministries. For more information: www.ucfunds.org.

The St. Pauls Giving and Finance Ministry monitors our portfolio monthly and we will schedule our next annual review with Matt Wagner, VP Institutional Relationships, this spring. St. Pauls' investment account grew to \$3,273,933. This performance is inclusive of \$198,996 in market gains and \$7,020 in net disbursements. Our holdings are 5% in cash and fixed income funds and 95% in a Balanced Fund account. The Balanced Fund's return in 2024 was 9.26%, reflecting 62.2% equity exposure, 37.0% fixed income exposure, and 0.8% in cash and equivalents.

The separate Capital Campaign fund ended 2024 with a balance of \$1,134,419. We will use these funds for Phase 2 of the Campaign to Expand and Elevate our Openness. This fund is invested 100% in the United Church Funds' Cash & Equivalent Fund.

St. Pauls maintains two checking accounts at Chase bank; at year end, our balance was \$525,542.

#### 2025 Budget

Council approved a 2025 budget that includes a deficit of \$172,718. Despite a substantial growth in pledged gifts, growth of expenses is greater. Construction related to the Capital Campaign limits increased use of our facilities by outside organizations through most of the year. We will develop strategies to increase facility use and revenue in 2026 after construction concludes.

**Income**: Our annual giving campaign resulted in 265 pledges totaling \$1,029,200 plus \$131,000 in matching funds, a record level. We budgeted \$1,050,000 because we anticipate receiving additional pledges throughout the year. We are employing best practices with regards to use of unrestricted planned gifts and use of Investment earnings. Specifically, we are limiting the unrestricted planned gifts used for operating expenses to 5% of the operating expenses. Use of investment funds will be limited to 4% of the average of the last five years ending balances to offset ebbs and flows in the market. The Giving and Finance Ministry developed an Investment Policy that the Church Council approved in 2024, which includes these tenets. We anticipate an 8% increase in income from Use of Building and Grounds. Chicago Public Schools paid its past due invoices and is now in good standing. Little Lights increased tuition fees; further growth is limited by construction associated with Phase 2 of the Campaign to Expand and Elevate our Openness.

As noted above, St. Pauls made an Employee Retention Credit Claim and expects to receive \$167,826. We budgeted this amount in 2024 but have not received. This Claim is similar to the Paycheck Protection Program credits we received in 2021 and 2022 – although the application was more complicated and we retained an agent who receives a commission based on the IRS payment. Thus, we need to look for continued Increases in giving and revenue from use of church assets. Larry Damron is leading a task force to explore increased revenue from church assets.

**Expenses**: Total expenses are budgeted to increase 6% from 2024. Staff and Administrative expenses continue to be our largest expense category. Council approved a 3% compensation increase, though individuals' increases will vary. Health insurance premium increases were relatively modest this year. We will incur CPA Fees in 2025 for the review of our 2023 books.

We renewed contracts with third party providers for Gas and Electric that kept those expenses in check in 2024. We believe it prudent to renew in 12-month intervals. There were substantial increases in building improvements, preservation, and operations lines, reflecting a commitment to preventive maintenance.

Worship and music budgets increased modestly. The invitational Outreach budget more than doubled to support our ambitious outreach goals to neighbors.

Modest budget cuts are evident in our Outreach category. There is no change to funding of Our Church's Wider Mission (OWCM) from the 2024 level. This is the contribution we make each year to the Illinois Conference of the UCC. In keeping with decisions made by several comparable churches, we reduced our contribution in 2024. We believe our continuing commitment of \$12,000 is justified because we are supporting the mission of the Illinois Conference by supporting Lighthouse UCC directly with rent-free space. The amount we distribute in other Annual Grants increased by 8%.

## Capital Campaign

"The Campaign to Expand and Elevate Our Openness"
Annual Report to the St. Pauls Congregation
February 25, 2025

October 20, 2024 will go down in Saint Pauls' history as the date that our congregation delivered on its eight-year commitment to make Saint Pauls fully accessible and more welcoming. This milestone moment was accomplished after Saint Pauls 1) raised a total of \$5.1 million to fund Phase I and II of the project – a Saint Pauls fundraising record – with \$3.4 million remaining to put toward Phase II, and 2) gained the congregation's endorsement to proceed with Phase II construction in 2025 to install a five-stop elevator and convert our courtyard into an open-air gathering plaza.

**Approval:** The motion approved unanimously by the Congregation at the October 20 Special Meeting of the Congregation read:

The Congregation moves to endorse the final recommended 2024 Phase II Capital Construction Plan as set forth by the Capital Campaign Committee, with construction to move forward in early 2025 and said construction funded by the following: 1) the existing >\$1.1 million campaign cash on hand, 2) a bridge line of credit from UCF's Cornerstone Fund to be repaid as the remaining >\$2.2 million pledged capital funds are paid through 2026, and

3) withdrawing up to \$950,000 from the St. Pauls Investment Fund to cover the balance of construction costs.

**Campaign:** The steps taken to accomplish Phase II of the congregation's long-planned, ambitious, and historic goal included:

- A First Quarter 2024 Phase II campaign fundraising launch. The effort was kicked off on February 4 with a post-Bible Off Broadway all-congregation brunch in the gym featuring an informational overview and the campaign fundraising video.
- Distribution of detailed campaign information packets and pledge solicitations to current and former members and friends.
- Gatherings and one-on-one outreach efforts to encourage pledging among current and former members, friends, church neighbors, and neighborhood organizations.
- Distribution of short weekly videos that highlighted the range of faith-based, social, growth-driving, educational, and safety benefits of the Phase II construction.
- An anonymous Capital Campaign pledge match challenge that generated over \$100,000 in new campaign pledges in just one week, which will be matched dollar for dollar by that generous donor household.

Phase II Construction Process: With the congregation's go-ahead in hand, the project team has 1) secured City of Chicago building permits, 2) requested a curb cut near the courtyard access ramp, 3) completed the process of applying for a Phase II bridge line of credit from the UCF's Cornerstone Fund, as was secured in Phase I, enabling us to pay contractors as pledge fulfillments come in through 2026, 4) completed a contract with general contractor Bulley & Andrews, and 5) completed site testing, solicited bids, and approved one contractor's submission for the required pre-construction asbestos abatement in the north end of the building.

The Phase II construction process begins in March and will continue through November, with the planned schedule as follows:

**Building Use:** Communication and preparations related to the building use implications of the Phase II construction have been ongoing. The Little Lights leadership has been fully informed of the construction plan and is implementing their plans for classroom/ equipment relocation as needed. Pastor Matt met with Lighthouse Church leaders in late December and included an update in his discussion. Choir music and robes have been relocated from the top floor Choir Room to the Social Hall. Access to the north end of the church complex will be available through the Fullerton Parkway entrance during the initial phases of Phase II. The existing lift will remain operational throughout Phase II.

**Pledging Continues:** Since the October Phase II approval, over \$15,000 in new pledges and donations have been received by the church. The signage around the construction site also will include the donation QR code so that interested neighborhood passers-by can contribute to the project. We encourage our recent new church members to add their support via a three-year campaign pledge, and our longer-term members and friends are encouraged to invite their friends and loved ones to contribute in honor of a birthday or anniversary or in memory of a loved one.

We thank the church staff for their cooperation in construction preparation. We thank the Council for their leadership and guidance. We thank the many who penned over 400 donor thank you notes expressing gratitude for campaign contributions. And, most of all, we thank our generous donors who have made this bold project possible.

We join our congregation and visitors in the sense of excitement and anticipation as we take this giant step forward in making Saint Pauls a more welcoming and accessible building complex. Current and future generations will benefit from this momentous effort.

## Pastor Jeff Carlson Annual Report

Jeff Carlson Associate Pastor 2024 Annual Report

2024 got off to a great start with Bible Off Broadway. This year's theme was the Parables of Jesus. Over 65 youth and adults participated. After that service, the gym was filled to capacity for a presentation on the Expand and Elevate Our Openness capital campaign, of which the second phase of the project has now begun!

In 2024 we trained and commissioned four new Stephen Ministers, Carrie Bruggers, Mollie McGrath, Mercedes Ridao and Jack Lyons. They experienced 50 hours of training, led by our Stephen Leader team of Marti Pechnyo, Barb Kaiser, Rick Peterson, Joe JaQuay and yours truly. We are thrilled to also have a new Stephen Leader on board, Nadia Jiménez.

We continued in relationship with UCAN, not just in financial support. We participated in their MLK Day event, laying groundwork for some collaboration on the 2025 event. UCAN staff came to present on their current work, especially in violence interruption. Additional justice presentations were led by One Northside on homelessness and LiveFree Illinois on a proposed Clean Slate Initiative for the previously incarcerated.

I led several Bible studies: Ecclesiastes; the Gospel of Mark - especially for Lent, culminating in a dramatic presentation by Mark Huddle; Revelation and going into Advent with 1 Thessalonians. Matt and I also led a C.S. Lewis in a year book group, reading the Chronicles of Narnia along with selected theological works by Lewis.

St. Pauls participated once again in the Pride Parade, although our numbers were smaller due to size restrictions implemented by the city. I used my piano skills to play for Taizé services in Lent and Advent, a Senior Lunch in November and a Christmas Carol singalong in December.

Our St. Pauls archive team has been reinvigorated, led by Barb Arsenault. I hosted a St. Pauls history presentation at Food for the Soul and we began work on highlighting women's history at St. Pauls.

We were thrilled to welcome some of our Spanish-speaking friends into church membership and with some bilingual baptisms. I am studying Spanish to improve my communication with them as their pastor. Part of that was a month of sabbatical studying in Spain. I'm grateful for that opportunity to get a jump start and I continue on-line classes three times a week.

Finally, it has been great to begin work with two of our new standing ministries: Activism & Advocacy and Care & Connections. The increased involvement of new members in these ministries is really a joyful and hopeful thing and new ideas and energy are percolating from all of our new ministry teams. I'm thrilled and grateful to God for all of the good things that are happening at St. Pauls, both spiritually and physically. God is good and it is such a joy to be in ministry with all of you at St. Pauls.

## Pastor Liz Nickerson Annual Report

At the start of each council meeting we repeat the strategic pillars of St. Pauls. Those pillars reflect the theme of Psalm 33 verse 11 above and they state that:

These pillars are reflected in everything we do at St. Pauls. Our church continues to grow and thrive because we have an eternal purpose and work at this purpose as a community. Which of these pillars resonates most with you? This year we have new ministry teams that were created when we made changes to the bylaws. The teams are doing marvelous work and people serve terms of 1-3 years. Every member is welcome to serve a term on these teams. In my role as an associate pastor, my worship duties include: preaching once a month, presiding over communion, baptizing children, and participating in funerals. I lead the Advent and Lenten Taize services, so if you haven't come to one yet, please come! This forty-minute contemplative service, without a sermon, incorporates ten minutes of meditative silence, and candle lighting, and it will restore your soul! Come to the Maundy Thursday service on April 10 at 7:30 PM to experience it. There will be a labyrinth walk at 7 PM in the gym prior to the service, so if you have never done that, it is a refreshing walking meditation that takes about 20 minutes. You will have another opportunity to walk the labyrinth on May 3, World Labyrinth Day when we will walk as one at 1:00 PM. People all over the world will walk labyrinths at I:00 PM in their time zone creating a continuous wave of peace throughout the world. In addition to worship, I have also engaged in pastoral care meetings with members and non-members, for counsel and prayer in coffee shops, hospitals, and nursing facilities.

I also serve as the pastoral liaison to the Children and Youth Ministry team, the Communications team, the Young Adult ministry, Little Lights, the Moms' group, and the Livestream team. The children's ministry at St. Pauls is growing. BOB was a huge success so special thanks to Jana O'Brien, Pastor

Jeff Carlson, and the entire BOB team!! We have wonderful Sunday school teachers this year, but we can always use more, so reach out if you have this gift. This year we are building service projects into the curriculum and developing an ongoing relationship with Belmont Village Retirement Home.. We are also focusing on building a stronger community among our families and had our first Family fondue night with over 50 people involved. It was a huge success! Special thanks to Youth ministry chair Molly McGrath for all of her work. Our confirmation program is strong and I attended a wonderful confirmation retreat in February with them as we joined confirmands from all over IL and WI at Stronghold camp. The key focus for Sunday school is for kids to learn to love God with all their heart, soul, and strength, and to love their neighbor as themselves.

Little Lights continues to grow and we have a weekly chapel led by Little Lights board President Tom Clancy and myself. The chapel theme comes from our Sunday school curriculum. Open gyms once a month began last winter and have been well received this year as well. Community building is happening through a recent potluck dinner, Christmas cookie exchange, and Valentine's Day party. The Little Lights board meets monthly. Our goal is to continue to integrate Little Lights and St. Pauls children's ministry with many combined events and develop age-appropriate service projects for families to participate in..

I started a weekday moms group in 2025 to supplement the Sunday group. This new group is made up primarily of moms whose children attend the Little Lights early learning program and many are becoming members of St. Pauls and having their children baptized! These are great groups and all are welcome.

I also serve as the pastoral liaison for Food for the Soul and the Live Stream/Digital Ministry Team. Food for the Soul is forging meaningful connections for adults at a monthly lunch. Come the 4th Tuesday of the month and join us. The live stream team has lots of great ideas and is constantly improving the live stream experience. They would love for others to join the team and help stream services. If you have an interest in this area, they can easily train you, so please reach out.

As noted above, this year our Christmas Eve offering of \$12,000 was designated for the Migrant Legal Fund and proceeds from the Advent Market of \$2,734 went to the Three Angels Children's Relief in Haiti.

Our congregation has focused the bulk of its advocacy and activism energy in the following areas during 2024:

- Refugee and Migrant support
- Environmental activism and green education
- Social justice and racial equity
- Anti Violence and support of UCAN

O&B would like to foster a deeper connection between the St Pauls community and the organizations we support financially, so members of the committee have been appointed as liaisons to connect with our grantees and organize practical volunteer opportunities in the coming year.

SPUCC Migrant Housing Program (David Brown)

In 2024, St. Pauls has continued their support of six migrant families under the leadership of David Brown, with the support and participation of countless volunteers. The new federal administration has presented difficulties such as loss of medical insurance coverage and fears of increased attention from ICE and other authorities. Here are some of the efforts St. Paul's has made to support these families in the past year:

- Continued legal support with assistance from Geoff Gist
- Continued support from mentors and sponsors from St. Pauls to navigate educational and medical issues.
- 'Know Your Rights' training to equip each family with an understanding of their rights if detained or confronted by authorities.

In the coming year, the ministry hopes to continue building funds to support legal assistance, provide education and childcare opportunities over the summer, and continue supporting the families in seeking affordable medical care.

#### GREEN TEAM (Barb Kaiser)

St Pauls established the Green Team in 2020 to help the congregation plan and take actions to implement our calling "to care for God's creation." Indeed, at our 2022 annual meeting, the Congregation authorized the Green Team to take steps to apply to the UCC for St Pauls to be recognized as an official "Creation Justice" church. This process is on-going. The Green Team has taken seriously its task of keeping the congregation informed of environmental and climate change issues. In addition to its weekly Creation Corner in the worship bulletin and the bulletin board outside the social hall, the Green Team has encouraged our pastoral staff to regularly refer to environmental justice concerns in their sermons and prayers. The Green Team has also continued supporting and planning a number of projects. In light of planned construction, the Green Team led the congregation in re-locating existing bulbs and vines to the Fullerton side of the church campus so that no material went to waste.

#### SPARC (Cindy Zinn Ball)

SPARC has continued their focus on racial justice and social awareness at St. Pauls. In February, Cindy Ball stepped down from leadership and the members of the group will continue to communicate with each other to raise awareness for causes and issues in the community.

#### Sharing the Table of Jesus

On communion Sundays in 2024 the St Pauls community collected food in the Narthex that we donated to the

Common Pantry, a food pantry, that was founded in 1967 to combat hunger and food insecurity in northern neighborhoods of Chicago.

Throughout 2024 St Pauls attendance and participation in volunteer and outreach activities has continued to grow, demonstrating the strength and engagement of our congregation; we are committed to living our faith in an age of injustice. Our St Pauls community is working to respond to current needs in our city and abroad and to shape the world around us through educational programs, volunteering

activities, and financial support. This is my first year as the leader of the Activism and Advocacy ministry, and I am very excited to continue deepening and realizing St. Paul's commitment to social justice.

#### **Greeting Team**

Greeters arrive at 9:30 a.m. and meet with ushers in the Narthex for quick announcements and a prayer. They then stand at the church doors and welcome attendees, greeting them with a smile, warm welcome and cheerfulness. Beginning December 2024, greeters will be scheduled by Worship & Adult Faith Formation Ministry.

## Moms' Group

This group is for moms with newborns through 10 years and meets after worship on the second Sunday of each month. Each month has a theme to explore to help participants become the best moms possible, support each other and form a tight-knit community. Powerful discussions happen and women are connecting to others that they have seen in worship but do not know well. Each meeting ends with prayer where members are grouped into twos, share prayer concerns and pray for each other. Additionally this group has begun to have social events together for fun and further bonding. In January of 2025 a weekday group has started on the last Thursday of each month, so there is a weekend and weekday group each month!

## **New Member Sponsors**

New member classes were offered by pastors throughout the year and joining Sundays (2/25, 4/21, 9/8 & 11/17) followed. As much as possible, new members were matched with sponsors who help welcome them to the congregation and assist with their integration into the life of the church. Sponsors play an integral role in helping new members transition into the body of Christ at St. Pauls.

#### **Stephen Ministry**

Their ministry includes:

- Communicating with congregation encouraging those in need of support through a tough time to reach out to ministry leaders
- Maintaining contact with matched care receiver weekly or as needed via Zoom, phone and other means
- Being available following worship to pray with anyone who wishes
- Serving as worship leaders occasionally
- Offering valuable support to each other, identifying and highlighting needs within the congregation
- Providing grief booklets to members and friends

New Stephen Ministry training was provided during the last quarter of 2024. Carrie Bruggers, Jack Lyons, Molly McGrath and Mercedes Ridao completed this training and are now commissioned as Stephen Ministers. Thanks to each of these individuals for pursuing this training and ministry. Thanks to Jeff Carlson, Joe JaQuay, Barbara Kaiser, Marti Pechnyo and Rick Peterson for leading this training.

Nadia Jimenez began Stephen Leader training to join the Leadership team. She will assist with coordinating activities of other team members.

Stephen Ministers receive ongoing education related to their role. On May 19 education related to hospice care was provided and the congregation was invited as well.

#### St. Pauls Social

This team hosts and assists others with a variety of social and fellowship events for adults. These provide opportunities to get to know others, form relationships and have fun. #### St. Pauls Young Adults

This group has continued to provide opportunities for faith, fun and fellowship for folks in their twenties and thirties. There are 27 people on their GroupMe app. All in this age group are welcomed. The Young Adult board of four members meets monthly to pray for each other and plan events with Pastor Liz Nickerson as their staff liaison. This group endeavors to sit together on Sunday mornings. ## **World Labyrinth Day**

- Initiated limited text opt-ins to members 18 and older.

## 4. Internal Organization & Process Improvements

- Planning ongoing efforts in data cleanup to improve contact management, communications preferences, and gathering member volunteer preferences.
- Developed an explainer document for the Capital Campaign vote.
- Provided an explainer document for the Annual Giving Campaign

#### Conclusion

The Communications Ministry has laid a strong foundation, community engagement, and technological integration. With clear action plans and dedicated volunteers, we are well-positioned to enhance how we connect with and serve the congregation in the coming months.

# **UCC** Representative Annual Report

## 2024 - 2025 Report of the United Church of Christ (UCC)

#### **2024 Illinois Conference Meeting**

On October 31 – November 2, 2024, the Illinois Conference of the United Church of Christ held its 2024 Annual Celebration/Meeting at the First Congregational Church of Western Springs. The theme was "Embrace God's Imagination." In addition to worship services and educational workshops, during the business meeting, the Illinois Conference considered two controversial matters:

Revised Constitution and Bylaws – After several years of discussion, the Illinois Conference unanimously adopted a revised Constitution and bylaws, with minimal and civil discussion (unlike previous attempts to modify the Illinois conference governing structure). These documents will become effective after the 2025 Illinois Conference Annual Meeting, where they may also be amended. During 2025, the Conference Council is charged with developing the specific implementation plans to allow the new structure to function.

The new Constitution, among other things, simplifies the conference governance structure, reduces the size of the Conference Council from 45 to 19 (and changes its name to Board of Directors), and establishes a Ministry Council to which the 4 standing ministry teams of the Conference will report (instead of the Board). The four ongoing ministry teams are the Community and Vitality Team, the Justice and Witness Team, the Church Connections Team and the Wider Engagement Team (within the UCC and with ecumenical partners).

<u>Illinois Conference Camps</u> – The Illinois Conference UCC operates two camps: Pilgrim Park, founded in 1946, in Princeton, IL; and Tower Hill, founded in 1923, in Sawyer, MI, with Lake Michigan access. Tower Hill is co-owned with the Community Renewal Society. These two camps are beloved by many, but have faced increasing challenges in recent years, including retaining staff and serving enough campers to be financially viable (which was especially an issue during the COVID pandemic).

In typical UCC fashion, a named committee was charged with reviewing the situation. The "Camp Forward" group, a diverse group of clergy and laypersons from around the Conference, gathered information, met with respected leaders of the "camp community," and developed recommendations for considered by the Conference. These recommendations were:

- That each camp should ultimately function as its own Not-for-Profit entity, but with a relationship to the Illinois Conference;
- That, to insure success over time, the Illinois Conference should make an incrementally reduced investment in each camp each year through 2029 (a total of \$300K); and
- That new committees and timelines should be established to unwind the financial business of the camps and to oversee the creation of new legal entities for the camps, with a goal of completion by January 1, 2026.

After considerable fruitful discussion, all three of these recommendations were adopted.

The Illinois Conference also adopted a \$1.23 M budget as proposed by the Finance Committee, which include reducing the percentage of money provided to the national setting to 20% of OCWM [Our

Church's Wider Mission] contributions (was about 35% ten years ago) and also including costs for a new Conference Minister search (former Conference Minister, Rev. Molly Carlson, tendered her resignation in the summer) and for the Illinois Conference and its delegates to attend and participate in the UCC General Synod 35.

## **UCC General Synod 35**

The UCC will hold General Synod 25 on July 11-15, 2025, in Kansas City, MO. The theme of General Synod 25 is "Into the Deep," citing Luke 5:4. Delegates from each of the Conferences and the UCC Board attend the General Synod at which the "business of the church" is conducted. UCC congregations are strongly encouraged to study Resolutions and Pronouncements adopted at General Synod, but are not bound by them; the list of the submitted resolutions to be considered by Synod 35 has not yet been released. During General Synod 34 in 2023, delegates narrowly voted to change the UCC bylaws so that General Synod gatherings will occur every three years instead of every two years, so General Synod 36 will meet in 2028.

## Current UCC Actions regarding plans of the Trump II

In the national setting, the UCC Office of Public Policy and Advocacy in Washington DC has been very active in raising the prophetic voice of the UCC on Capital Hill. It has been providing the faith community with the tools to stay informed and take action during the first period of the Trump II administration, "countering Project 25 with Love." It also provides model letters and phone scripts for individuals to consider using with their Senators and Representatives. <a href="https://www.ucc.org/first100days/">https://www.ucc.org/first100days/</a> [This site is updated on at least a weekly basis.]

The UCC Office of Public Policy and Advocacy, following the actions of the UCC General Synods over time, have identified the following policy priorities for 2025:

- Immigration;
- Environmental Justice;
- LGBTQ rights/Reproductive Justice;
- Protecting Human Needs funding and program;
- Addressing war and conflict abroad; and
- U.S. Militarization.

In addition, specifically as UCC relates to environmental issues, the UCC Climate Action Assembly has established a "Climate Hope Affiliates" program to follow-up on the Climate Hope Voter pledge cards campaign from last fall. In this affiliate program, members of congregations will meet with Members of Congress and local media periodically to share views and advocate for environmental justice in the workings of Congress. St Pauls' Green Team has requested information about becoming one of these Climate Hope Affiliates.

## **Future of the UCC**

As of 2022, the UCC had 4603 congregations and 712,296 members in the US, showing a decline from previous years, including a net loss of 286,000 members and 551 congregations between 2012 and

2022. In 2022, the average UCC church size was 153 members and average worship attendance was 52. Nearly half (49%) of all UCC congregations had fewer than 100 members.

At General Synod 32 in 2023, the Rev. Karen Georgia Thompson was elected to be the UCC's first female and immigrant President and General Minister. In her nomination speech, Thompson said the "hope springs forth" within the UCC, with the denomination being "the place where we have seen the Spirit of God poured forth among us in many ways. Here is where we honor the resilience of those who came before us, who took risks and oftentimes did more with less than we currently have. And here is the place we identify as now, as we ponder the call of God to be salt and light to the world."

In her compelling recently re-published book, *How We Learn to Be Brave*, Mariann Edgard Budde, Episcopal Bishop of Washington recounts a discussion with colleagues regarding the future of her denomination. She said "*If this ship is going down, I'm going down with it – but not without doing everything I can to keep that from happening.*" (pg. 77)

Personally, I feel the same way about the UCC. While the UCC denomination becomes smaller in numbers, it stands for the things in which I believe and speaks when the voice of progressive Christianity is necessary and urgent – and I hope and pray that St Pauls UCC is similarly supportive.
